Reopening of the terms of application

for the degree course in **MARITIME SCIENCE AND TECHNOLOGY (class L-28) – GE headquarters**
curriculum in **ENGINEER OFFICER AND ELECTRO-TECHNICAL OFFICER**

HAVING REGARD	to the notice of admission to the degree course in MARITIME SCIENCE AND TECHNOLOGY (class L-28) , issued by Rector's Decree no. 2049 of 17 May 2021, which provides for 25 places available (of which 3 for non-EU students resident abroad) for the <i>curriculum in</i> ENGINEER OFFICER AND ELECTRO-TECHNICAL OFFICER ;
HAVING REGARD	to the merit lists published on 21 July 2021 pursuant to art. 8 of the aforementioned notice of admission;
HAVING CONSIDERED	that 9 candidates have been placed in a useful position in the ranking for the <i>curriculum in</i> ENGINEER OFFICER AND ELECTRO-TECHNICAL OFFICER , 1 of whom in the ranking reserved for non-EU students resident abroad;
HAVING CONSIDERED	the procedure for finalising the enrolment of candidates placed in a useful position on the list will end on 24 August 2021;
HAVING HELD	that it is necessary to prepare the appropriate and necessary actions to fill the 16 places that would still be available at the end of the enrolment procedure described above;
HAVING CONSIDERED	the need and opportunity to conclude the selection and enrolment of candidates by a deadline before the beginning of the lessons;

The Director of the Teaching Area provides the following:
